FINAL ORDER FOLLOWING CONFERENCE HEARING

NOW, on this 18th day of October, 1997, this matter comes on for conference proceedings before the Kansas Board of Healing Arts ("Board") at the request of Christy McGrown ("Applicant") to grant an extension to the second temporary registration.

Charlene K. Abbott, Licensing Administrator, presents information before the Board. There are no other appearances.

After reviewing the file, hearing information and being duly advised in the premises, the Board makes the following findings of fact, conclusions of law and orders:

FINAL ORDER FOLLOWING CONFERENCE HEARING

1. A written request for an extension was received in the Board office on September 8, 1997, from Applicant.

2. Notice of Conference Hearing setting this matter for hearing at 12:30 p.m. on October 18, 1997 was filed herein on October 3, 1997 and served on Applicant on that same date.

3. Applicant has applied for permanent registration as a respiratory therapist, but has not passed an examination approved by the Board as required by K.S.A. 65-5506(a)(3).

4. Applicant was granted a second temporary registration, # 9723882, on June 28, 1997 and which expired September 30, 1997.

5. The Board finds that sufficient cause exists to grant Applicant an extension to her second temporary registration to June 30, 1998.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED as follows:

A. That an extension to the second temporary registration be granted to Applicant to expire June 30, 1998.

B. That this is a Final Order and is effective upon service upon the parties. Any party may, within fifteen (15) days after service, file a Petition for

Reconsideration. The filing of a Petition for Reconsideration is not a prerequisite for seeking administrative or judicial review.

IT IS SO ORDERED.


