JOURNAL ENTRY OF SATISFACTION OF CONSENT ORDER

COMES NOW the Kansas State Board of Healing Arts (“Board”), by and through its Executive Director, Kathleen Selzler Lippert, a duly authorized representative of the Board, in accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-501 *et seq.*, as amended, and upon due consideration of the agency record and applicable statutes and regulations, and being otherwise duly advised in the premises, makes the following determinations:

1. On or about December 9, 2013, Licensee entered into a Consent Order with the Board for alleged violations of the Kansas Physician Assistant Licensure Act, K.S.A. 65-28a01, *et seq.* The Board accepted and ratified this Consent Order on approximately February 24, 2014. The Consent Order required Licensee attend and successfully complete the continuing education course UC San Diego PACE Program’s Anger Management for Healthcare Professionals Program, and to provide the Board documentation evidencing completion of the same by September 1, 2014.

2. On or about August 28, 2014, Licensee submitted documentation evidencing completion of “Anger Management for Healthcare Professionals Program” presented by UC San Diego PACE Program, which Licensee completed on approximately May 21-23, 2014.


3. Licensee has satisfactorily met all requirements of the Consent Order and has no


