Findings of Fact			
1. Barbara Ann McKeown, O.T.A. ("Li	censee") was originally issued license number		
18-00603 to practice as an occupational therapy assistant in the state of Kansas on August 6, 2004.			
Licensee's license is currently active.			
2. Licensee's last known mailing addre	ess as provided to the Board at the time of her		
application for reinstatement is (confidential)	Kansas City, Missouri 64118.		
3. On or about June 8, 2009, the Board received an application from Licensee for			
reinstatement of her occupational therapy assistant lie	cense. Licensee's license had been cancelled for		

failure to renew on May 1, 2009.

- 4. In section 6 of her application, Licensee lists all professional activities since the cancellation of her license. Licensee states that she worked as an OTA, CEAS II for Athletic & Rehabilitation Center from May 1, 2009 to June 1, 2009, when she saw that her Kansas license was overdue.
- 5. Licensee's license was reinstated on June 29, 2009. Licensee worked from May 1, 2009 until June 1, 2009 as an occupational therapy assistant without being properly licensed.

Applicable Law

- 6. K.S.A. 65-5410 states, in pertinent part: (a) The Board may deny, refuse to renew, suspend, revoke or limit a license or the licensee may be publicly or privately censured where the licensee or applicant for licensure has been guilty of unprofessional conduct which has endangered the health, welfare or safety of the public. Unprofessional conduct includes:
 - (2) being guilty of unprofessional conduct as defined by rules and regulations adopted by the board;
 - (c) The board, in addition to any other penalty prescribed in subsection (a), may assess a civil fine, after proper notice and an opportunity to be heard, against a licensee for unprofessional conduct in an amount not to exceed \$5000 for the first violation. . . .
- 7. K.A.R. 100-54-5 Unprofessional conduct; defined. Unprofessional conduct means any of the following:
 - (o) committing conduct likely to deceive, defraud or harm the public

Conclusions of Law

8. The Board has jurisdiction over Licensee as well as the subject matter of this proceeding, and such proceeding is held in the public interest.

- 9. That by continuing to be employed as an occupational therapy assistant from May 1, 2009 to June 1, 2009, Licensee was holding herself out to the public as an individual properly licensed by the Kansas State Board of Healing Arts to assist in the practice of occupational therapy, by doing so Licensee engaged in conduct likely to deceive, defraud or harm the public in violation of K.S.A. 65-5410(2) in combination with K.A.R. 100-54-5.
- 10. The Board finds that Licensee engaged in unprofessional conduct as defined by K.A.R. 100-54-5 by continuing to be employed as an occupational therapy assistant without being properly licensed.
- Based on the facts and circumstances set forth herein, it appears that the use of summary proceedings in this matter is appropriate, in accordance with the provisions set forth in K.S.A. 77-537(a), in that the use of summary proceedings does not violate any provision of the law and the protection of the public interest does not require the Board to give notice and opportunity to participate to persons other than Licensee, Barbara Ann McKeown, O.T.A.

IT IS, THEREFORE, ORDERED that Licensee is hereby assessed a civil fine of \$150.00 due and payable within thirty days of the effective date of this Order.

A party to whom a Summary Order is issued may file a written request for a hearing pursuant to K.S.A. 77-542 within 15 days following service of the Summary Order.
