**JOURNAL ENTRY ON APPROVAL OF CONSENT ORDER
WITH MODIFICATIONS**

On December 14, 2018, the parties appeared before the Kansas Board of Healing Arts (Board) for a conference hearing on the approval of the Consent Order in the above captioned matter. Allen McLain, D.O. (Licensee) appeared in person. Susan Gering, Deputy Litigation Counsel, appeared as litigation counsel for the Board. The parties submitted a proposed Consent Order, executed by Applicant on October 25, 2018, for the Board’s review and approval. Upon review of the proposed consent order, and taking into consideration the statements and testimony received at the hearing, the Board approved the Consent Order with the following changes as agreed by all parties:

1. Paragraph 48 is amended to add the following requirement:
 - a. “During Licensee’s term of supervision, Licensee shall not act as supervisor for any physician assistant (PA) or advanced practice registered nurse (APRN).”

2. Paragraph 73 is amended to include the following sentence:
 - a. “Licensee shall refrain from the practice of osteopathic medicine and surgery until such time as the arrangements required by the supervision and educational preceptor provisions of this Consent Order are approved by the Board and are in place.”

THEREFORE, the Consent Order executed by Licensee on October 25, 2018, and submitted to the Board for review and approval at the December 14, 2018 Board meeting, is hereby **APPROVED** with the agreed **MODIFICATIONS** ordered herein.


