FINAL ORDER

NOW ON THIS 27th day of April, 1996, comes on for hearing Petitioner's Motion for Limited Review and Respondent's Request for Review. Petitioner, State Board of Healing Arts, appears through Kevin K. LaChance, Disciplinary Counsel. Respondent appears in person and through Brian C. Wright, Attorney at Law.

Upon hearing the arguments of counsel, and having the agency record before it, the Board affirms the findings of the hearing officer as set forth in the Initial Order. The Initial Order is otherwise modified as follows: The order of the hearing officer suspending the license of Ambrosio P. Mendiola, M.D. for a period of 180 days, is upheld, and such suspension shall be in effect between the dates of July 1, 1995 and December 28, 1995. Commencing on the effective date of this Final Order, the license of Ambrosio P. Mendiola, M.D. is limited. Such limitation shall terminate one year following the date of service of this final order. The limitation shall require a chart review of all patient encounters by an individual licensed to practice medicine and surgery who is nominated by Respondent and approved by the

Board. Such person shall report to the Board in writing and on a quarterly basis explaining the number of charts reviewed, whether Respondent is practicing within the applicable standard of care, and what recommendations or comments are made to improve Respondent's quality of care. The provisions of the stipulation agreement dated February 15, 1991 are no longer in effect. The costs of this action are assessed against Respondent.

This is a final order. It is effective upon service. A party may seek relief from this order by filing a petition for judicial review with the district court. A petition for judicial review is not timely unless filed within thirty days following service of the Final Order, except that such time is extended during the pendency of timely attempts to exhaust administrative remedies.

A party may seek reconsideration of this Final Order by the Board by filing a petition for reconsideration within 15 days following service of this Final Order. A petition for reconsideration is not a prerequisite to judicial review.

Any petition for judicial review or for reconsideration must be served upon the Executive Director for the Board.


