**FINAL ORDER GRANTING
TERMINATION OF CONSENT ORDER**

NOW on this 10th day of April, 2015, comes before the Kansas State Board of Healing Arts (“Board”) Petitioner’s Motion to Modify the Consent Order previously entered in this matter. Christie M. Mensch, M.D. (“Licensee”) appears in person, and by and through counsel, Carol Ruth Bonebrake of Simpson, Logback, Lynch, Norris, P.A. Jane Weiler, Associate Litigation Counsel, appears on behalf of the Respondent Board.

Pursuant to the authority granted to Board by K.S.A. 65-2801 *et seq.* and in accordance with the provisions of the Kansas Administrative Procedure Act K.S.A. 77-501 *et seq.*, the Board hereby enters this Final Order in the above-captioned matter. After reviewing the agency record, hearing the statements and arguments of the parties, receiving exhibits into evidence, and being otherwise duly advised in the premises, the Board makes the following findings, conclusions and order:

1. Licensee is licensed to engage in the practice of medicine and surgery in the State of Kansas, having been issued License No. 04-31837 on approximately April 8, 2006.
2. On or about March 9, 2012, Licensee entered into a Consent Order with the Board.
3. The Consent Order required Licensee to **Confidential**

to enter into and complete the Psychiatric Residency Training Program at KU and to not engage in the practice of medicine outside of the residency program. The Consent Order further stated that the terms of the Consent Order were not self-terminating and that after completing the residency program, Licensee could request modification or termination of the provisions of the Consent Order.

4. On or about February 24, 2015, Licensee filed a Motion to Modify Consent Order. In her motion, Licensee requested that Confidential submit quarterly reports to the Board regarding her progress as opposed to monthly reports, the frequency of Confidential be at least once per week or as recommended Confidential Confidential and that upon completion of her residency program in June of 2015, that the limitation on her license to only practice medicine and surgery within her residency program be lifted.

5. At the conference hearing on this matter Licensee and her counsel requested to amend the motion to modify the consent order to a motion for termination of the consent order and Confidential Confidential Confidential

6. Based on the evidence presented, the Board finds that Licensee has met the compliance requirements of her Consent Order.


7. The Board concludes that Licensee's motion to terminate her Consent Order shall be granted upon her completion of her psychiatric residency program. Licensee shall provide to the Board as soon as possible documentary evidence of her completion of her residency program. Upon receipt of such confirmation the limitation on her license shall be terminated.

Pursuant to K.S.A. 77-529, Licensee may petition the Board for Reconsideration of a Final Order within fifteen (15) days following service of the final order. Additionally, a party to an agency proceeding may seek judicial review of a Final Order by filing a petition in the District Court, as authorized by K.S.A. 77-601, *et seq.* Reconsideration of a Final Order is not a prerequisite to judicial review. A petition for judicial review is not timely unless filed within **30 days** following service of the Final Order. 
