- 1. On or about May 16, 2016, in accordance with K.S.A. 2015 Supp. 77-537 and 77-514, and as authorized by K.S.A. 65-2836, a Summary Order was issued ordering that the license of Dennis W. Miller, M.D. ("Licensee") to practice medicine and surgery in the State of Kansas be indefinitely suspended until such time as he changes his licensure status from Active to Inactive or Exempt as required pursuant to the Consent Order in KSBHA Docket No. 16-HA00005.
- 2. Pursuant to K.S.A. 77-542, the Summary Order notified Licensee that if a written request for a hearing was not filed within fifteen (15) days following service of the Summary Order, the Summary Order would become effective as a Final Order upon expiration of the time for requesting a hearing.
