JOURNAL ENTRY DISMISSING SUMMARY ORDER

COMES NOW the Kansas State Board of Healing Arts (“Board”), by and through its Executive Director, Kathleen Selzler Lippert, a duly authorized representative of the Board, in accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-501 *et seq.*, as amended, and upon due consideration of the agency record and applicable statutes and regulations, and being otherwise duly advised in the premises, makes the following determinations:

1. On or about May 16, 2016, in accordance with K.S.A. 2015 Supp. 77-537 and 77-514, and as authorized by K.S.A. 65-2836, a Summary Order was issued ordering that the license of Dennis W. Miller, M.D. (“Licensee”) to practice medicine and surgery in the State of Kansas be indefinitely suspended until such time as he changes his licensure status from Active to Inactive or Exempt as required pursuant to the Consent Order in KSBHA Docket No. 16-HA00005.

2. Pursuant to K.S.A. 77-542, the Summary Order notified Licensee that if a written request for a hearing was not filed within fifteen (15) days following service of the Summary Order, the Summary Order would become effective as a Final Order upon expiration of the time for requesting a hearing.


3. On or about May 24, 2016, Licensee changed his license status to Exempt as

required pursuant to the Consent Order in KSBHA Docket No. 16-HA00005, as a result the Summary Order in Docket No. 16-HA00100 did not become a Final Order.

IT IS THEREFORE ORDERED that the Summary Order issued on May 16, 2016 is hereby dismissed.


