

## PROPOSED DEFAULT ORDER DENYING APPLICATION FOR LICENSURE

NOW on this 11th day of October, 2013, comes on for hearing before the Kansas State Board of Healing Arts ("Board") the Application for License to Practice Radiologic Technology of Kellie Miller, L.R.T. ("Applicant"). Jessica Bryson, Associate Litigation Counsel, appears on behalf of the Respondent Board. Applicant fails to appear.

Pursuant to the authority granted to the Board by K.S.A. 65-7301 et seq. and in accordance with the provisions of the Kansas Administrative Procedure Act K.S.A. 77-501 et seq., the Board hereby enters this Proposed Default Order in the above-captioned matter.

Having the agency record before it, the Board finds, concludes and orders as follows:

- 1. On or about January 17, 2013, Kellie Miller, L.R.T. ("Applicant") submitted to the Board an application for license to practice radiologic technology in the State of Kansas. Such application was deemed complete and filed with the Board on September 3, 2013.
- Applicant's mailing address as provided to the Board is: Confidential 2. Lee's Summit, MO 64063.
- 3. A conference hearing on Applicant's application for licensure was noticed for October 11, 2013 at the offices of the Kansas State Board of Healing Arts.

4. Pursuant to K.S.A. 2012 Supp. 77-531, Applicant was served with a Notice of

Conference Hearing to Applicant's mailing address via United States Mail, first-class postage

prepaid, on or about September 19, 2013.

5. The Notice of Conference Hearing provided Applicant notice that any party who

fails to attend or participate in the Conference Hearing or other stage of a proceeding may be

held in default.

6. Applicant failed to appear at the Conference Hearing held on October 11, 2013.

7. Pursuant to K.S.A. 77-516 and K.S.A. 2012 Supp. 77-520, Licensee is in default

for her failure to appear at the conference hearing on October 11, 2013.

8. Upon review of the agency record and after being fully advised in the premises,

the Board finds and concludes that the facts and allegations set forth in the Response in

Opposition to Application for license to practice radiologic technology are undisputed.

9. The Board concludes Applicant's application should be denied for violations of

K.S.A. 65-7313(a)(8), as further defined by K.A.R. 100-73-6(h) and (c).

IT IS THEREFORE ORDERED, BY THE KANSAS STATE BOARD OF

**HEALING ARTS** that Licensee is hereby held in **DEFAULT** pursuant to K.S.A. 77-520.

IT IS FURTHER ORDERED that Applicant's Application for Licensure is **DENIED**.
