ORDER FOLLOWING CONFERENCE HEARING

NOW on this 27th day of April, 1996, this matter comes on for conference proceedings before the Kansas State Board of Healing Arts (hereafter "Board"), at the request of Abdul Rauf Mir, M.D. (hereinafter "Applicant") to waive the requirement of providing the professional school transcript, which requirement appears at Section X of the Application for Endorsement.

Charlene K. Abbott, Licensing Administrator, presents information to the Kansas Board of Healing Arts. There are no other appearances.

After reviewing the file, hearing statements of the parties and being duly advised in the premises, the Board makes the following findings of fact, conclusions of law and orders:

- 1. Applicant's Application for Endorsement was received on March 23, 1994.
- 2. Applicant's request for waiver of the transcript requirement was received on April 8, 1996.
- Notice of Conference Hearing setting this matter for hearing at 10:00 a.m. on April 27, 1996 was filed herein on April 11, 1996 and served on Applicant on that same date.
- 4. Applicant has been unable to obtain the transcript from the professional college he attended to fully satisfy the requirement of Section X of the Application for Endorsement. He has provided the certificate of professional college.

5. The Board has determined that Applicant is in substantial conformity with K.A.R.

100-8-2(e) and therefore, sufficient cause exists to waive the transcript requirement on Applicant's

Application for Endorsement.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that the transcript

requirement of Section X of Applicant's Application for Endorsement is hereby waived.

IT IS FURTHER ORDERED that waiver of the transcript requirement does not constitute

approval of Applicant's Application for Endorsement, nor does it constitute a waiver of any other

requirement of the application.

IT IS FURTHER ORDERED that this is a Final Order and is effective upon service upon

the parties. Any party may, within fifteen (15) days after service, file a Petition for Reconsideration.

The filing of a Petition for Reconsideration is not a prerequisite for seeking administrative or judicial

review.

IT IS SO ORDERED.
