JOURNAL ENTRY

COMES NOW the Kansas State Board of Healing Arts (“Board”), by and through its Executive Director, Kathleen Selzler Lippert, in accordance with the Kansas Administrative Procedure Act, K.S.A. 77-501 *et seq.*, as amended, and upon consideration of the file, applicable statutes and regulations, and being otherwise duly advised in the premises, makes the following determinations:

1. John R. Mitchell, Jr., O.T. (“Licensee”) has, since approximately July 11, 2001, maintained License No. 17-01967 to engage in the practice of occupational therapy in the State of Kansas.
2. On or about June 22, 2010, Licensee entered into a Consent Order with the Board (“Consent Order”) for alleged violations of the Occupational Therapy Practice Act, K.S.A. 65-5401, *et seq.* The Consent Order contained the following terms: Licensee was publicly censured for violating the Occupational Therapy Practice Act; Licensee was required to attend and successfully complete a Board-approved continuing education course for record-keeping by September 1, 2010, and provide the board with documentation demonstrating successful completion of the course by September 15, 2010; and, Licensee was required to attend and successfully complete a Board-approved continuing education course for billing practices by September 1, 2010, and provide the board with documentation demonstrating successful

completion of the course by September 15, 2010.


3. The Board record reflects that, on or about August 11, 2010, Licensee satisfied the provision of the Consent Order requiring successful completion of a Board-approved remedial billing practices course.

4. The Board record reflects that, on or about April 13, 2011, Licensee satisfied the provision of the Consent Order requiring successful completion of a Board-approved remedial medical record-keeping course.


5. Licensee has satisfied all requirements of the Consent Order and has no further obligation for compliance.

IT IS THEREFORE ORDERED that Licensee has satisfied all terms and conditions of the Consent Order filed on June 22, 2010, and that the allegations set forth in the Consent Order shall be deemed resolved without entry of further order.
