FINAL ORDER GRANTING LICENSURE

NOW on this 11th day of October 2013, comes before the Kansas State Board of Healing Arts ("Board") the application of Sohaib Mohiuddin, M.D. ("Applicant") for a license to practice medicine and surgery in the State of Kansas. Applicant appears in person and by and through counsel, Mark Stafford. Jessica Bryson, Associate Litigation Counsel, appears on behalf of the Respondent Board.

Pursuant to the authority granted to the Board by the Kansas Healing Arts Act, K.S.A. 65-2801, *et seq.* and in accordance with the provisions of the Kansas Administrative Procedure Act K.S.A. 77-501, *et seq.*, the Board hereby enters this Final Order in the above-captioned matter. After reviewing the agency record, hearing the statements and arguments of the parties, and being otherwise duly advised in the premises, the Board makes the following findings, conclusions and order:

- 1. On or about January 17, 2013, Applicant submitted an application to the Board for a license to practice medicine and surgery in the State of Kansas. Such application was complete and filed with the Board on September 12, 2013.
- 2. Applicant has held Kansas post-graduate training permit no. 94-07629, which became effective on July 1, 2011.

3. On September 12, 2013, Associate Litigation Counsel filed a Response to

Application for License to Practice Medicine and Surgery alleging there may be grounds for

denial due to Applicant being placed on academic probation during his residency training and

based on Applicant's explanatory statements in his application materials regarding his "yes"

answers to the application's disciplinary questions regarding his residency probations and a

closed Massachusetts Board investigation.

4. The Board finds that Applicant was placed on academic probation by two

residency programs which may be grounds for denial of licensure pursuant to K.S.A. 65-2836(s).

However, the Board finds Applicant's testimony explaining the circumstances surrounding these

actions to be persuasive. Additionally, Applicant has since successfully progressed in his current

residency program at the University of Kansas School of Medicine-Wichita such that there is no

present concern about his clinical competency or professionalism which would warrant denial of

licensure.

5. The Board finds that Applicant's explanatory statements in his application

materials about his "yes" answers are not misrepresentative or misleading. Some of his

statements appear to represent Applicant's personal opinions regarding the circumstances

underlying his residency probations, but they do not misrepresent the bases for the actions taken.

Additionally, Applicant submitted copies of official documentation of his residency probations

and the closed Massachusetts Board investigation which fully disclosed the underlying facts and

circumstances for each.

6. The Board finds there is no evidence that Applicant committed misrepresentation

in his application pursuant to K.S.A. 65-2836(a).

7. The Board concludes that Applicant's application for licensure should be granted.

IT IS THEREFORE ORDERED, BY THE KANSAS STATE BOARD OF HEALING ARTS that Applicant is hereby GRANTED a license by examination to practice as medicine and surgery in the State of Kansas.
