SUMMARY ORDER

NOW ON THIS 26th day of Nov, 2013, this matter comes before Kathleen Selzler Lippert, Executive Director, Kansas State Board of Healing Arts ("Board"), in summary proceedings pursuant to K.S.A. 77-537.

Pursuant to K.S.A. 77-537, this Summary Order shall become effective as a Final Order, without further notice, if no request for hearing is made within fifteen (15) days of service.

Upon review of the agency record and being duly advised in the premises, the following findings of fact, conclusions of law and order are made for and on behalf of the Board:

Findings of Fact

1. Frances J. Moody, R.T. ("Licensee") was originally issued license number 16-04055 to practice as a respiratory therapist in the State of Kansas on or about April 7, 2011. Licensee's current license designation is active, and such license was last renewed on or about May 1, 2013.

2. Licensee's last known mailing address as provided to the Board is **Confidential** Liberty, Missouri 64068.

3. This Summary Order incorporates herein by reference the facts as stated in the Summary Order that was filed September 10, 2013, in KSBHA Docket No. 14-HA00033.

4. The September 10, 2013, Summary Order ordered Licensee to pay the assessed civil fine, pursuant to K.S.A. 65-5510(c) in the amount of \$100.00 for violation of the Kansas Respiratory Therapy Practice Act.

5. On or about October 25, 2013, Licensee remitted full payment in the amount of \$100.00 to the Kansas State Board of Healing Arts for satisfaction of her civil fine.

6. Additionally, the September 10, 2013, Summary Order ordered Licensee to complete twelve (12) contact hours of continuing education, and submit proof of completion of the continuing education requirement within thirty (30) days following service of the September 10, 2013, Summary Order.

7. Licensee has not provided to the Board proof of successful completion of the twelve (12) hours of continuing education as ordered pursuant to the September 10, 2013 Summary Order.

Applicable Law

8. K.S.A. 65-5510(a) states in pertinent part:

The board may deny, refuse to renew, suspend, revoke or limit a license or the licensee may be publicly or privately censured where the licensee or applicant for licensure has been guilty of unprofessional conduct which has endangered or is likely to endanger the health, welfare or safety of the public. Unprofessional conduct includes:... (2) being guilty of unprofessional conduct as defined by rules and regulations adopted by the board;...(4) violating any lawful order ... of the board.

9. K.A.R. 100-55-5 states in pertinent part:

“Unprofessional conduct” means any of the following...(h) failing to furnish to the board, ... or its representatives, any information legally requested by the board.

Conclusions of Law

10. The Board has jurisdiction over Licensee as well as the subject matter of this proceeding, and such proceeding is held in the public interest.

11. The Board finds that Licensee violated K.S.A. 65-5510(a)(4) in that Licensee violated a lawful order of the Board previously issued by the Board in KSBHA Docket No. 14-HA00033.

12. The Board additionally finds that Licensee violated K.S.A. 65-5510(a)(2) by being guilty of unprofessional conduct as further defined by K.A.R. 100-55-5(h) by failing to furnish a Board representative the legally requested information, being proof of the completion of twelve (12) hours of continuing education as requested to be provided pursuant to the lawful order of the Board previously issued by the Board in KSBHA Docket No. 14-HA00033.


13. Based on the facts and circumstances set forth herein, it appears that the use of summary proceedings in this matter is appropriate, in accordance with the provisions set forth in K.S.A. 77-537(a), in that the use of summary proceedings does not violate any provision of the law and the protection of the public interest does not require the Board to give notice and opportunity to participate to persons other than Licensee, Frances J. Moody, R.T.

IT IS, THEREFORE, ORDERED that Licensee is hereby **INDEFINITELY SUSPENDED** for Licensee's violations of the Respiratory Therapy Practice Act. Licensee shall be Indefinitely Suspended until such time as she provides to the Board proof of successful completion of the twelve (12) contact hours of continuing education as ordered pursuant to the September 10, 2013, Summary Order in KSBHA Docket No. 14-HA00033.

PLEASE TAKE NOTICE that upon becoming effective as a Final Order, this document shall be deemed a public record and be reported to any reporting entities authorized to receive such disclosure.


