**SUMMARY ORDER DENYING REQUEST FOR WAIVER OF REINSTATEMENT FEE**

NOW, on this 10th day of February, 2001, this matter comes before the Kansas State Board of Healing Arts (hereafter "Board") in summary proceedings pursuant to K.S.A. 77-537. Charlene K. Abbott, Licensing Administrator, presented information before the Board. There were no other appearances.

After hearing statements from the Licensing Administrator and being duly advised in the premises, the following findings of fact, conclusions of law and orders are made for and on behalf of the Board:

1. The license of Robert F. Moore, M.D. (hereafter "Licensee") was issued by the Board on June 15, 1956.
2. On August 1, 2000, Licensee's license was canceled for failure to renew for the period of July 1, 2000 through June 30, 2001.
3. On November 21, 2000, Licensee filed an Application for Reinstatement of his canceled license. Additionally, Licensee asked that the Board waive the fee required for reinstatement of a canceled license.
4. On Saturday, February 10, 2001, Licensee's request for waiver of the reinstatement fee was presented to the Board for determination.

5. K.S.A. 2000 Supp. 65-2809 states that any license canceled for failure to renew may be reinstated upon payment of the renewal fees then due.

6. K.A.R. 100-11-1 establishes the fee for reinstatement of a canceled license at \$300 and makes no provision for waiver of the fee.

7. Licensee's request for waiver of the reinstatement of the fee should be denied.


**IT IS THEREFORE ORDERED** that Licensee's request for waiver of the reinstatement fee of \$300 is **DENIED**.

This is a Summary Order and either party is entitled to a review if a written request is received in the Board office within 15 days of service of the Order upon the parties. If no request is received, this Order will become immediately effective.

**IT IS SO ORDERED.**


