FINAL ORDER

NOW ON THIS Fourteenth Day of October, 2000, comes before the Board of Healing Arts for a Conference Hearing the Petition to Revoke, Suspend, or Otherwise Limit Licensure of Jeffrey Moran, M.D. Kelly J. Benintendi, Associate Counsel, appears for Petitioner. Respondent appears *pro se*. After hearing the statements of the parties, and having the agency record before it, the Board finds, concludes and orders as follows:

1. Respondent is licensed by the Board to engage in the practice of medicine and surgery. Respondent was also licensed to practice medicine and surgery in the State of California.

2. The Division of Medical Quality of the California Department of Consumer Affairs revoked Respondent's California license by an order dated February 28, 2000. The order became effective March 29, 2000.

3. Respondent was notified that the California board had initiated the administrative action on October 30, 1998. He failed to inform the Board of the disciplinary action as required when filing his Kansas renewal application June 1, 1999. The Board concludes that Respondent committed fraud or misrepresentation in applying for renewal of his license.

4. The grounds for the California board action included negligence, professional incompetence, dishonesty and corruption, sexual relations with a patient, and prescribing without

medical indication. Based upon the findings of fact made by the California board to support these grounds, the Board concludes that the California board's action revoking the license was based upon facts that would be grounds for discipline under the healing arts act.

5. The Board may revoke, suspend, limit or deny a license, and a licensee may be fined or censured, if another state's licensing board takes disciplinary action for conduct which would also constitute grounds for discipline under the healing arts act. K.S.A. 1999 Supp. 65-2836(j) and (s).

6. The Board may also revoke, suspend, limit or deny a license, and a licensee may be fined or censured, if a licensee commits fraud or misrepresentation in applying for renewal of a license. K.S.A. 1999 Supp. 65-2836(a).


7. Considering the underlying conduct that resulted in the California board action, the Board finds that Respondent's license should be revoked.

IT IS, THEREFORE, ORDERED that Respondent's license to practice the healing arts is hereby revoked.

PLEASE TAKE NOTICE that this is a Final Order. A Final Order is effective when served. A party may file a petition for judicial review of a Final Order with the clerk of the district court within 30 days following service of the Final Order. Reconsideration is not a prerequisite for review. A copy of any petition for review must be served upon the Executive Director for the Board at 235 S. Topeka Blvd., Topeka, Kansas 66603.
