SUMMARY ORDER OF CANCELLATION OF LICENSE

NOW, on this 28th day of March, 1994, this matter comes before Lawrence T. Buening, Jr., serving as Presiding Officer in summary proceedings. Licensee does not appear.

The Presiding Officer specifies the following findings of fact, conclusions of law and reasons for actions:

1. The registration of Brenda C. Morris, aka Bohannon (hereafter "Registrant") issued by the Kansas State Board of Healing Arts (hereafter "Board") as a Respiratory Therapist in the State of Kansas expired December 31, 1993, pursuant to K.A.R. 100-55-6.

2. On or about January 15, 1994, the Board gave Registrant a second notice that the registration had expired and provided a Notice of Proposed Cancellation of Registration that if a fully completed application for renewal, the annual renewal fee of \$30.00 and additional late fee of \$5.00 was not received postmarked by February 1, 1994, a Conference Hearing would be held February 8, 1994, at 11:00 a.m. to consider the cancellation of the registration.

3. On or about January 31, 1994, the Board received Registrant's application for renewal and a check numbered #1255 drawn on the Bank IV of Lawrence in the sum of \$35.00

4. As a result of receipt of said check and application for renewal, Registrant was issued receipt #9485769 indicating Registrant's registration to practice in the State of Kansas had been renewed for the period January 1, 1994, through March 31, 1995.

5. On February 11, 1994, the Board received notification from the State Treasurer that Registrant's aforementioned check had been returned not paid because of insufficient funds in the account and Registrant has been advised on numerous occasions of the return of the check but has failed to pay the annual fee of \$30.00 together with the additional fee of \$5.00.


6. Registrant's registration to practice as a Respiratory Therapist in the State of Kansas should be cancelled due to failure to renew as provided by K.S.A. 65-5512.

IT IS THEREFORE ORDERED that the registration of Registrant issued by the Board to practice as a Respiratory Therapist in the State of Kansas is cancelled.

IT IS FURTHER ORDERED that Registrant is entitled to request a hearing on this Order, in writing, to the Kansas State Board of Healing Arts, 235 South Topeka Boulevard, Topeka, Kansas 66603-3068 within five (5) days of service of this Order and if a hearing is not requested within the time and manner as stated above, this decision becomes final and effective upon the expiration of the time for requesting a hearing.
