**FINAL ORDER**

NOW on this 20<sup>th</sup> day of October, 2001, comes on for Conference Hearing before the Kansas State Board of Healing Arts ("Board"), the Petition to Revoke, Suspend or Otherwise Limit License filed September 28, 2001. Kelli J. Benintendi, Associate Counsel for the Board ("Petitioner"), appears for and on behalf of the Board. Bruce D. Moses, Jr., MD ("Licensee") appears in person. There are no other appearances.

Petitioner presents arguments and exhibits and then rests. Licensee admits all of the allegations contained in the Petition to Revoke, Suspend or Otherwise Limit License and offers to surrender his license to practice medicine and surgery in the state of Kansas.

After hearing the arguments and statements of the parties, reviewing the agency record and being otherwise duly advised in the premises, the Board finds as follows:

1. There is no dispute as to any material fact concerning the allegations as set forth in Counts I, II and II of the Petition to Revoke, Suspend or Otherwise Limit License.
2. The Board should accept the surrender of Licensee's license, such occurring during the pendency of disciplinary proceedings.


3. Acceptance of the surrender of Licensee's license is not deemed a revocation of the license. Licensee may, at reasonable intervals, seek reinstatement of his license by the filing of a completed Application for Reinstatement and payment of the appropriate reinstatement fees, at which times the Board will consider whether Licensee has demonstrated that he can resume the competent practice of medicine and surgery with reasonable skill and safety to patients.

**IT IS, THEREFORE, BY THE BOARD ORDERED** that the offer of Licensee to surrender his license to practice medicine and surgery in the state of Kansas is accepted.

**PLEASE TAKE NOTICE** that this is a Final Order. A Final Order is effective upon service. A party may seek judicial review of a Final Order by filing a petition un the Kansas act for judicial review and civil enforcement of agency actions, K.S.A. 77-601, *et seq.* A petition for judicial review is not timely unless filed within 30 days of the Final Order. A copy of any such petition must be served upon the Board addressed to the Executive Director, 235 S. Topeka Blvd., Topeka, Kansas 66603. A petition for reconsideration is not a prerequisite to judicial review.
