FINAL ORDER FOLLOWING CONFERENCE HEARING

NOW, on this 12th day of February, 2000, comes before the Kansas Board of Healing Arts, (hereafter "Board") the request to sit for Step 3 of the USMLE examination a seventh time by Paul D. Munyer, M.D. (hereafter "Applicant"). Charlene K. Abbott, Licensing Administrator, presented information to the Board. There were no other appearances.

After reviewing the file and being duly advised in the premises, the Board finds as follows:

1. On December 15, 1999, a Summary Order was issued regarding Applicant's request to sit for the USMLE examination a seventh time. The Board does not customarily approve a request to sit for the exam a seventh time and Applicant's record did not indicate any compelling reason to allow him to sit for the USMLE examination a seventh time and therefore his request was denied.
2. On December 22, 1999, Applicant filed a request for a hearing on the Board's denial of his ability to sit for the USMLE examination for a seventh time.
3. A Notice of Conference Hearing was filed in the Board office on January 19, 2000, and mailed on January 20, 2000, setting this matter for Conference Hearing before the full Board on Saturday, February 12, 2000.

4. On February 7, 2000, by letter to Charlene K. Abbott, Applicant requested that the Board abandon his appeal of the December 15, 1999 Summary Order.


5. On February 12, 2000, Ms. Abbott advised the Board that Applicant requested withdrawal of his request for a hearing on the Summary Order issued by the Board that denied his request to sit for the USMLE a seventh time.

6. At the Conference Hearing held on February 12, 2000, after reviewing the file, hearing statements from Ms. Abbott and being otherwise duly advised in the premises, the Board approved Applicant's request for withdrawal of his request for a hearing.

IT IS THEREFORE ORDERED AS FOLLOWS:

Applicant's request for withdrawal of his appeal of the Board's Summary Order in a Conference Hearing is hereby withdrawn and no further proceedings are required or necessary.


