**ORDER TERMINATING STIPULATION  
AND DISSOLVING ENFORCEMENT ORDER**

**NOW**, on the 13th day of December, 1991, comes on for Summary Proceedings the request of Walter S. Murphy, D.P.M., (Licensee) for termination of Kansas Podiatry Act Compliance Monitoring Program and removal of license limitation as previously issued by the Kansas Board of Healing Arts (Board) on October 25, 1990.

Licensee does not appear. Board Litigation Counsel, Steve A. Schwarm, appears on behalf of the Board. There are no other appearances.

The Board takes administrative notice that by letter dated October 4, 1991, Licensee requested the Board that he be released from the Kansas Podiatry Act Compliance Monitoring Program. Licensee indicates that he has fulfilled all requirements as set forth in the Final Order within the specified time limits.

After reviewing the file and being otherwise duly advised in the premises, the Kansas State Board of Healing Arts makes the following Findings of Fact and Conclusions of Law and Order:

1. On October 29, 1990 a Final Order captioned "In The Matter of Walter S. Murphy, D.P.M., Kansas License No. 12-00133, Before the Board of Healing Arts of the State of Kansas, Case No. 90-DC-0190" was filed over the authorizing Board signature of Franklin Bichlmeier, M.D., Board President. The October 29, 1990 Final Order stated that the Podiatry license of Licensee was "hereby limited and Licensee is placed under the Kansas Podiatry Act Compliance Monitoring Program to be administered by the Kansas Board of Healing Arts Legal Section...".

2. Licensee has submitted evidence of successful completion of all requirements of the Kansas Podiatry Act Compliance Monitoring Program and has complied with all provisions of the Kansas Podiatry Act Compliance Monitoring Program in a timely fashion.

3. Litigation Counsel for the Board states that all information received under the Kansas Podiatry Act Compliance Monitoring Program is favorable to the Licensee and no additional adverse information of any nature whatsoever has been received by the Board relative to the Licensee in case number 90-DC-0190 or any other matter relative to the jurisdiction of the Board.

4. The Final Order instituting the Kansas Podiatry Act Compliance Monitoring Program shall be terminated and any limitation or other provisions placed on Licensee shall be dissolved.

5. With the termination of the requirements as set forth in the Final Order and dissolution of any limitations placed on Licensee's license, Licensee shall be discharged from any restrictions or limitations thereby imposed on his license to practice Podiatry in the State of Kansas.

IT IS THEREFORE ORDERED by the Board that the conditions, limitations and provisions of the Kansas Podiatry Act Compliance Monitoring Program instituted in response to the Final Order filed October 29, 1990 between Licensee and the Board shall be terminated in its entirety and shall hereafter have no further force or effect and the license of Licensee to practice Podiatry in the State of Kansas shall hereafter be without restriction or limitation.
