JOURNAL ENTRY OF SATISFACTION OF FINAL ORDER

COMES NOW the Kansas State Board of Healing Arts (“Board”), by and through its Executive Director, Kathleen Selzler Lippert, a duly authorized representative of the Board, in accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-501 *et seq.*, as amended, and upon due consideration of the file and applicable statutes and regulations, and being otherwise duly advised in the premises, makes the following determinations:

1. Percy C. Myers, M.D. (“Licensee”) has, since approximately February 1, 1979, maintained License No. 04-18010 to engage in the practice of medicine and surgery in the State of Kansas.

2. On or about December 16, 2010, the Board, in accordance with K.S.A. 77-527, issued a Final Order accepting and adopting the Initial Order issued by Presiding Officer Michael J. Beezley, M.D. following a formal hearing. The formal hearing was held based on Licensee’s request for a hearing on a Summary Order issued for violations of the Kansas Healing Arts Act, K.S.A. 65-2801, *et seq.* The Final Order required Licensee pay a fine in the amount of \$500.00, and costs in the amount of \$337.00, which were both due in full and payable to the Board.

3. The Board record reflects that, on or about February 20, 2012, Licensee paid the \$500.00 fine and the \$337.00 costs in full.


4. Licensee has satisfactorily met all requirements of the Final Order and has no further obligation for compliance.


