**FINAL ORDER FOLLOWING CONFERENCE HEARING**

NOW, on this 23rd day of June, 1995, comes on for consideration before the Kansas State Board of Healing Arts ("Board") sitting as a whole as Presiding Officer in a conference proceeding pursuant to the provisions of K.S.A. 77-533 through 77-535 the application of Bidadi S. Nagaraj, M.D. ("Applicant") for licensure by endorsement to practice medicine and surgery in the State of Kansas. Charlene Abbott, Licensing Administrator, presented information before the Board. Applicant did not appear.

After reviewing the application and being otherwise duly advised in the premises, the Board finds as follows:

**FINDINGS OF FACT**

1. On May 8, 1995, Applicant filed an application for endorsement to obtain a license to practice medicine and surgery in the State of Kansas.

2. As part of his application, Applicant provided evidence he graduated from Bangalore Medical College in Bangalore, India.

3. Bangalore Medical College is not a healing arts school which has been accredited or approved by the Board.

4. Under K.S.A. 65-2873(c)(1), an applicant for licensure from an unapproved healing arts school must complete 3 years of postgraduate training as approved by the Board.

5. The information provided by Applicant does not reflect completion of any postgraduate training in the United States and the Board cannot approve the postgraduate training obtained by Applicant as being acceptable to meet the requirements of K.S.A. 65-2873(c)(1).

**CONCLUSIONS OF LAW**

The fact that Applicant has not completed three years of postgraduate training approved by the Board constitutes grounds for which the Board may deny an application for licensure by endorsement to practice medicine and surgery in the State of Kansas pursuant to K.S.A. 65-2873(c)(1).

**IT IS THEREFORE BY THE BOARD ORDERED** as follows:

A. That the findings herein above made be and the same are made the Order of the Board.

B. Based upon the Board's failure to approve Applicant's postgraduate training as meeting the requirements of K.S.A. 65-2873(c)(1), Applicant has not met the qualifications necessary to obtain a license to practice medicine and surgery and Applicant's application for license is **DENIED**.


