## FINAL ORDER TERMINATING PROBATION

**NOW**, on this 21<sup>st</sup> day of October 2011, comes before the Kansas State Board of Healing Arts ("Board") the Motion of Nick A. Navato, D.O. ("Licensee") for Termination of Probation under the terms of a Consent Order filed in this matter. Licensee appears *pro se*. Janith A. Lewis, Associate Litigation Counsel, appears on behalf of the Respondent Board.

Pursuant to the authority granted to the Board by the Kansas Healing Arts Act, K.S.A. 65-2801, *et seq.*, and in accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-501, *et seq.*, the Board hereby enters this Final Order following a conference hearing in the above-captioned matter. After reviewing the file, hearing the testimony and arguments of the parties, and being otherwise duly advised in the premises, the Board makes the following findings, conclusions and order:

- Licensee is licensed to engage in the practice of osteopathic medicine and surgery
  in the State of Kansas, License No. 05-27198, and has been so licensed since approximately
  August 16, 1997.
- 2. On or about March 1, 2011, Licensee entered into a Consent Order with the Board which imposed a term of probation upon Licensee's license which required him to complete a continuing education course in record-keeping with a minimum of six (6) months follow-up chart review; complete a continuing education course in prescribing of controlled substances; and submit proof successful completion of both courses by April 30, 2011.

3. The terms of the Consent Order allow Licensee to petition the Board for

modification or termination of the probation after completion of the education requirements.

4. On or about September 21, 2011, Licensee requested the Board terminate the term

of probation of Licensee's license.

5. On or about September 22, 2011, the Respondent Board filed a neutral Response

to Licensee's request.

6. Licensee has submitted proof of successful completion of medical record keeping

and physician prescribing courses through PACE at the University of California, Sand Diego

School of Medicine.

7. License has also submitted a satisfactory summary of the Evaluation and

Management chart review conducted by Physicians Business Network, in Overland Park,

Kansas.

8. Licensee has sufficiently completed all required provisions of his probation and

termination is warranted.

IT IS THEREFORE ORDERED, BY THE KANSAS STATE BOARD OF

**HEALING ARTS** that the probation of Licensee's license is hereby terminated.
