#### **INITIAL ORDER**

NOW ON THIS Fifteenth Day of October 2002, this matter comes on for a formal hearing before Raymond N. Conley, D.C. Stacy L. Cook, Litigation Counsel, appears for Petitioner. Respondent appears *pro se*.

After hearing the statements of the parties, the Presiding Officer finds, concludes and orders as follows:

1. Respondent does not dispute that he has been convicted of driving under the influence (Confidential)

2. Respondent offers to surrender his license to practice chiropractic (confidential)
(Confidential)

(Confidential) This offer of surrender is made with the knowledge that the matter will be reported to the National Practitioner Data Bank pursuant to federal law, and with the knowledge that as a condition to reinstating his license, Respondent must show clear and convincing evidence of rehabilitation and

that he is able to practice chiropractic with skill and safety.

3. The parties agree that the provisions of K.S.A. 65-2844 do not apply to Respondent's

future efforts to reinstate his license. That statute precludes an application for reinstatement for three

years following revocation of a license.

4. The parties agree that without a license, Respondent does not have the financial

ability to pay the costs of this proceeding, and that any assessment of costs should be made at the

time Respondent seeks reinstatement of his license.

5. A protective order is appropriate to preserve the confidentiality of the exhibits offered

in this case. The parties are ordered not to disclose those exhibits unless ordered by the Board or by

a court of competent jurisdiction. This protective order shall not prevent the parties from using any

portion of the agency record in any future proceeding before the Board in which Respondent is a

party.

IT IS, THEREFORE, ORDERED that the Board accepts Respondent's offer to surrender

his license to practice chiropractic.

PLEASE TAKE NOTICE that the Board will conduct review of this Initial Order and issue

a Final Order on December 14, 2002 at 10:00 a.m., or as soon thereafter as time permits. This order

will not become effective as a Final Order until approved by the Board following review.
