FINAL ORDER

NOW on this Twenty-third Day of April, 2005, comes before the Board the request of Licensee, Michael H. Nielson, M.D., seeking termination of the limitations imposed by the July 2001 order granting reinstatement of license with limitations.

Having the agency records before it, and having heard the statements of the parties, the Board finds, concludes and orders as follows:

1. Licensee was originally issued license number 4-14225 on July 1, 1969.
2. License Number 4-14225 was canceled for failure to renew on August 1, 1996.
3. On July 24, 2001 licensee was reinstated by *Order Granting Application for Reinstatement of License to Practice Medicine and Surgery with Limitation*.
4. On December 31, 2004 the Board received Licensee's request for removal of all restrictions on his license.
5. Licensee has complied with the requirements of the July 24, 2001 order.
6. The Board finds that good cause exists to terminate the limitations upon Licensee's license.

IT IS THEREFORE ORDERED that the limitations imposed in the July 24, 2001 *Order Granting Application for Reinstatement of License to Practice Medicine and Surgery*

with Limitation are hereby terminated. Licensee shall continue to comply with the Healing Arts Act, all regulations of the Board and all state and federal laws as well as keep the Board informed of his current home and work telephone numbers and addresses by notifying the Board in writing within 10 days of any change.

PLEASE TAKE NOTICE this is a Final Order. A Final Order is effective upon service. A party may seek judicial review of a Final Order by filing a petition under the Kansas act for judicial review and civil enforcement of agency actions, K.S.A 77-601, *et seq.* A copy of any such petition must be served upon the Board addressed to the Executive Director, 235 S. Topeka Blvd., Topeka, Kansas 66603. Reconsideration is not a prerequisite to judicial review.
