FINAL ORDER FOLLOWING CONFERENCE HEARING

NOW, on this 19th day of October, 1991, comes on for consideration before the Kansas State Board of Healing Arts (hereafter "Board"), the Application for License by Endorsement to practice medicine and surgery in the State of Kansas filed by Shafaat A. Nomani, M.D. (hereafter "Applicant").

Applicant appears not. Steve A. Schwarm, Litigation Counsel for the Board, appears.

After reviewing the file and being otherwise duly advised in the premises, the Board makes the following findings of fact and order:

1. On October 4, 1991, Applicant filed an Application for License by Endorsement to practice medicine and surgery in the State of Kansas.

2. As part of the aforementioned Application, Applicant did not complete § X thereof entitled "Certificate of Professional College".

3. Prior to the date of this hearing, Applicant has provided all of the appropriate information to comply with § X of the Application and K.A.R. 100-8-2(e).

IT IS THEREFORE BY THE BOARD ORDERED that the Application for Endorsement filed by Applicant is complete and should be approved and a license to practice medicine and surgery be issued to Applicant.

IT IS FURTHER ORDERED that this is a Final Order and is effective upon service upon the parties. Any party may, within 15 days after service, file a Petition for Reconsideration. The filing of a Petition for Reconsideration is not a prerequisite for seeking administrative or judicial review.

IT IS SO ORDERED.
