COMES NOW the Kansas State Board of Healing Arts (“Board”), by and through its Executive Director, Kathleen Selzler Lippert, a duly authorized representative of the Board, in accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-501 et seq., as amended, and upon due consideration of the file and applicable statutes and regulations, and being otherwise duly advised in the premises, makes the following determinations:

1. On or about January 24, 2011, Licensee entered into a Consent Order with the Board for alleged violations of the Kansas Physical Therapy Practice Act, K.S.A. 65-2901, *et seq.* The Consent Order included education requirements requiring Licensee to attend and successfully complete two leadership courses approved by the Board, and to provide the Board documentation evidencing completion of the same by September 30, 2011.

2. The Board record reflects that, on or about September 19, 2011, Licensee provided the Board with documentation evidencing successful completion of the education requirements.


3. Licensee has satisfactorily met all requirements of the Consent Order and has no further obligation for compliance.

**IT IS THEREFORE ORDERED** that Licensee is hereby discharged from all requirements of the Consent Order filed on March 1, 2011.


