## AGREED ORDER AMENDING EDUCATION REQUIREMENT OF CONSENT ORDER

COMES NOW, the Kansas State Board of Healing Arts, ("Board"), by and through Associate Litigation Counsel, Lori D. Dougherty ("Petitioner"), and Licensee-Respondent Nicholas Notario, P.T. ("Licensee"), pro se, and presents this Agreed Order Amending the Educational Requirement of the Consent Order filed march 1, 2011. The parties stipulate and agree to the following:

- 1. On February 22, 2011, the Board approved Licensee's Consent Order. The Consent Order listed two educational courses approved by Disciplinary Panel No. 25 and the Physical Therapy Council.
- 2. The courses contemplated by the Consent Order are:
  - a. Intermediate Independent Leadership Project Registration; and
  - b. Leading Others: Adaptive & Transformational Leadership in Physical Therapy;
- 3. Licensee is required to submit proof of completion to the Compliance Coordinator by September 30, 2011.
- 4. Licensee was informed that the course "Leading Others: Adaptive & Transformational Leadership in Physical Therapy" is the third class in the series and that he must take "Lead Wherever You Are: Becoming a Personal Leader" as a prerequisite.
- 5. "Lead Wherever You Are: Becoming a Personal Leader" is offered April 29 through May 1, 2011, in Fort Worth, Texas.
- 6. Licensee has requested being allowed to take "Lead Wherever You Are: Becoming a Personal Leader" in lieu of "Leading Others: Adaptive & Transformational Leadership in Physical Therapy."
- 7. This request to substitute "Lead Wherever You Are: Becoming a Personal Leader" in lieu of "Leading Others: Adaptive & Transformational Leadership in Physical Therapy" was

submitted to Disciplinary Panel No. 25 and the Physical Therapy Council. Both the Panel and the Council approved the substitution.

- 8. Licensee must still take the Intermediate Independent Leadership Project.
- 9. License must turn in proof of completion of both continuing education courses to the Compliance Coordinator by September 30, 2011.
- 10. All other terms and conditions of the Consent Order filed March 1, 2011 remain in full force and effect.
