FINAL ORDER GRANTING LICENSURE BY ENDORSEMENT

NOW on this 17th day of June 2011, comes before the Kansas State Board of Healing Arts (“Board”) the application of Noureddin Nourmohammadi, M.D. (“Applicant”) for a license to practice medicine and surgery in the State of Kansas, and request for licensure by endorsement. Licensee appears *pro se* by telephone. Jessica Bryson, Associate Litigation Counsel, appears on behalf of the Respondent Board.

Pursuant to the authority granted to Board by K.S.A. 65-2801 *et seq.* and in accordance with the provisions of the Kansas Administrative Procedure Act K.S.A. 77-501 *et seq.*, the Board hereby enters this Final Order in the above-captioned matter following a conference hearing. After reviewing the file, hearing the statements and arguments of Ms. Bryson, hearing the testimony of the Applicant and being otherwise duly advised in the premises, the Board makes the following findings of fact, conclusions and order:

1. Applicant submitted to the Board an application for a license to practice medicine and surgery in the State of Kansas. Licensee also requested licensure by endorsement. Such application was deemed complete and filed with the Board on May 18, 2011.

2. Licensee’s mailing address provided to the Board is: confidential

3. Applicant received his Doctor of Medicine degree from Mashad University in Iran in June of 1970.

4. Applicant has been unable to provide the Board with certified copies of his healing arts school documentation in conjunction with his application. As such, Applicant does not meet the application requirements set forth in K.A.R. 100-6-4 for a license by examination.


5. Applicant holds active and unrestricted medical licenses in California and Maryland.

6. Applicant has actively engaged in practice in Maryland since 1987.

7. Applicant has satisfactorily demonstrated that he is qualified to receive a license by endorsement pursuant to K.S.A. 65-2833 based on his licenses in California and Maryland.

IT IS THEREFORE ORDERED, BY THE KANSAS STATE BOARD OF HEALING ARTS that Applicant is hereby granted a license by endorsement to practice medicine and surgery in Kansas effective June 17, 2011.


