FINAL ORDER FOLLOWING CONFERENCE HEARING

NOW, on this 13th day of August, 1994, comes on for conference proceedings the request of Samwel O. Odinga, (hereafter "Applicant") to grant Second Temporary Permit pursuant to K.A.R. 100-36-1.

Applicant does not appear. Charlene K. Abbott, Licensing Administrator, appears on behalf of the Board. There are no other appearances.

After reviewing the files and being duly advised in the premises, the Kansas State Board of Healing Arts (hereafter "Board") makes the following findings of facts, conclusions of law and order:

1. A request for a Second Temporary Permit was filed by Applicant on July 10, 1994.

2. Notice of Conference Hearing setting this matter for hearing at 9:30 a.m. on August 13, 1994 was filed herein on July 28, 1994 and served on Applicant on that same date.

3. Applicant has applied for permanent registration as a occupational therapist, but has not passed an exam approved by the Board as required by K.S.A. 65-5406.

4. Applicant was granted a temporary permit on July 14, 1993 which expired July 14, 1994.

5. Pursuant to KSA 65-5408 (d) no more than one such temporary permit shall be permitted to any one person without the majority approval of the members of the Board.

6. Applicant took the examination administered on July 22, 1994 and is awaiting the results thereof.

7. Applicant should be granted a second temporary permit retroactively effective to July 14, 1994 and to expire on October 15, 1994, the next meeting of the Board.

IT IS THEREFORE ORDERED that a second temporary permit for the purposes of holding oneself out as a occupational therapist be issued to Applicant retroactively effective from July 14, 1994 and to expire on October 15, 1994 upon payment of the required fee for such second temporary permit.

IT IS FURTHER ORDERED that this is a Final Order and is effective upon service upon the parties. Any party may, within 15 days after service, file a Petition for Reconsideration. The filing of a Petition for Reconsideration is not a prerequisite for seeking administrative or judicial review.

IT IS SO ORDERED.
