JOURNAL ENTRY

COMES NOW the Kansas State Board of Healing Arts (“Board”), by and through its Executive Director, Kathleen Selzler Lippert, in accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-501 *et seq.*, as amended, and upon due consideration of the file and the applicable statutes and otherwise being duly advised in the premises, makes the following determinations:

1. Mr. Okoye is licensed to engage in the practice of respiratory therapy in the State of Kansas, having been issued License No. 16-02843 on approximately July 5, 2002.
2. Mr. Okoye’s last known mailing address provided to the Board is P.O. Box 414671, Kansas City, Missouri, 64141.
3. On or about February 15, 2012, the Board served, via United States mail, Mr. Okoye with a Petition at both his mailing and residential addresses of record.
4. The Petition was never returned to the Board as undeliverable.
5. The Petition states that it would be appropriate to set the matter for hearing at the next available Board meeting scheduled for April 13, 2012.
6. Pursuant to K.S.A. 2010 Supp. 77-531, Licensee was served with a Notice of Conference Hearing to Licensee’s last known address by United States Mail, first-class postage prepaid, on March 21, 2012.

7. The Notice states that a Conference Hearing will be held on April 13, 2012 at 10:30 a.m. or as soon as thereafter as the parties can be heard.

8. The Notice of Conference Hearing provided Licensee notice that any party who fails to attend or participate in the Conference Hearing or other stage of a proceeding may be held in default under the Kansas Administrative Procedure Act.

9. Licensee failed to appear at the conference hearing on April 13, 2012.

10. Pursuant to K.S.A. 77-516 and K.S.A. 2010 Supp. 77-520, Licensee was in default for his failure to appear at the conference hearing on April 13, 2012. Upon review of the agency record and after being fully advised, the Board found and concluded that the allegations against Licensee, as stated in the Petition, were deemed undisputed.

11. On May 2, 2012, a Proposed Default Order was issued against Licensee and copies of the Proposed Default Order were mailed to Licensee's last known address by United States Mail, first-class postage prepaid.

12. Pursuant to K.S.A. 2010 Supp. 77-520, the Proposed Default Order notified Licensee that the order would become effective as a Final Order of the Board seven (7) calendar days following service of the order, unless within that seven (7) day period Licensee filed a written motion with the Board requesting that the proposed default order be vacated.


13. Licensee failed to file a Motion to Vacate the Proposed Default Order within the seven (7) day period following service of the order.

14. Pursuant to K.S.A. 77-520 and 77531, the Proposed Default Order became effective as a Final Order on May 12, 2012, and Licensee's license to practice respiratory therapy in the State of Kansas was **REVOKED**.



PROPOSED DEFAULT ORDER

NOW on this 13th day of April, 2012, comes on for hearing before the Kansas State Board of Healing Arts ("Board") in the disciplinary matter of Francis O. Okoye, R.T. ("Applicant"). Jessica Bryson, Associate Litigation Counsel, appears on behalf of the Respondent Board. Mr. Okoye fails to appear.

Pursuant to the authority granted to the Board by K.S.A. 65-5510 *et seq.* and in accordance with the provisions of the Kansas Administrative Procedure Act K.S.A. 77-501 *et seq.*, the Board hereby enters this Default Order in the above-captioned matter.

Having the agency record before it, the Board finds, concludes and orders as follows:

1. Mr. Okoye was licensed to engage in the practice of respiratory therapy in the State of Kansas, having been issued License No. 16-02843 on approximately July 5, 2002.
2. Mr. Okoye's last known mailing address provided to the Board is P.O. Box 414671, Kansas City, Missouri, 64141.
3. On or about February 15, 2012, the Board served, via United States mail, Mr. Okoye with a Petition at both his mailing and residential addresses of record.
4. The Petition was never returned to the Board as undeliverable.

10. Additionally, the allegations contained in the Petition that Mr. Okoye violated K.S.A. 65-5510(a), K.S.A. 65-5510(a)(2), K.S.A. 65-5510(a)(2), and K.S.A. 65-5510(a)(2) are deemed admitted.


14. Pursuant to K.S.A. 65-5510 *et seq.*, there are grounds to revoke Mr. Okoye's license to practice respiratory therapy.
