SUMMARY ORDER

NOW ON THIS 10th day of Sept., 2013, this matter comes before Kathleen Selzler Lippert, Executive Director, Kansas State Board of Healing Arts ("Board"), in summary proceedings pursuant to K.S.A. 77-537. This Summary Order shall become effective as a Final Order, without further notice, upon the expiration of the fifteen (15) day period if no request for hearing is made, pursuant to K.S.A. 77-542.

Upon review of the agency record and being duly advised in the premises, the following findings of fact, conclusions of law and order are made for and on behalf of the Board:

Findings of Fact

1. Sallie J. Olomon, O.T. ("Licensee"), **Confidential** Garden City, Kansas, 67846, is licensed to practice as an occupational therapist in the State of Kansas, License No. 17-01601, and has been so licensed since November 6, 1998.

2. Pursuant to K.A.R. 100-54-6, Licensee's license to practice as an occupational therapist in the State of Kansas expires on March 31 of each year. On or about March 30, 2013, Licensee submitted an application for licensure renewal.

3. Pursuant to K.S.A. 65-5412 and K.A.R. 100-54-7, each licensee desiring to renew an occupational therapist license must have completed at least forty (40) contact hours of continuing education during the preceding 24-month period. Each licensee shall provide proof of satisfactory completion of the continuing education requirements to the Board upon request.

4. As part of the renewal process, Licensee certified that she had read the rules regarding the continuing education requirements and the Board's procedures for auditing continuing education. Licensee further certified that she had completed at least forty (40) contact hours of continuing education during the preceding 24-month period and that documentation of the completed continuing education would be maintained for a three-year period and produced to the Board upon request.

5. Licensee was randomly selected to provide verification of compliance with the continuing education requirements.

6. On or about June 3, 2013, a letter was mailed to Licensee requesting that Licensee provide, no later than July 3, 2013, the records relied upon when Licensee certified completion of the required continuing education.

7. On or about July 1, 2013, an email was sent to the licensee reminding her of the upcoming deadline of July 3, 2013, for submitting the continuing education.

8. On or about July 10, 2013, a certified letter was mailed to Licensee requesting that Licensee provide, no later than August 1, 2013, the records relied upon when Licensee certified completion of the required continuing education.

9. On or about July 31, 2013, an email was sent to Licensee reminding her of the upcoming final deadline of August 1, 2013 for submitting the continuing education.

10. On or about July 31, 2013, Licensee submitted proof of 32 hours of continuing education plus two (2) hours for professional reading, however, Licensee was still short six (6) hours of continuing education.

11. On or about August 1, 2013, a letter was sent to Licensee informing her that she was short six (6) hours and requesting the additional hours by August 9, 2013.

12. On or about August 2, 2013, the Licensee had not claimed the certified letter sent to her on July 10, 2013, and it was returned to the Board.

13. On or about August 22, 2013, the Board emailed Licensee in attempt determine whether Licensee had the six (6) hours needed to fulfill her continuing education requirements.

14. Licensee failed to comply with the Board's request to provide documented evidence of compliance with the continuing education requirements by the deadline.

15. By failing to provide documented evidence of completion of the continuing education requirements, Licensee violated K.S.A. 65-5410(a)(4) by violating any lawful order or rule and regulation of the Board. Specifically, Licensee violated K.A.R. 100-54-5(g) by failing to furnish to the Board, or to its investigators or representatives, any information legally requested by the Board.

16. Licensee violated K.S.A. 65-5410(a)(2) by committing an act of unprofessional conduct as defined by K.A.R. 100-54-5(g); specifically, failing to furnish to the Board, or to its investigators or representatives, any information legally requested by the Board.

17. In addition to any other penalty prescribed under the Occupational Therapy Practice Act, K.S.A. 65-5410(c) authorizes the Board to assess a civil fine in an amount not exceeding \$5,000 for the first violation of the Occupational Therapy Practice Act.

IT IS, HEREBY ORDERED BY THE KANSAS STATE BOARD OF HEALING ARTS THAT:

18. Licensee is hereby assessed a CIVIL FINE for failure to comply with the Board's legal request for information.

19. Licensee is hereby ordered to pay the assessed CIVIL FINE pursuant to K.S.A. 65-5410(c) in the amount of **\$100.00**. The total amount of **\$100.00** shall be due on or before October 15, 2013.


20. Licensee shall make all payments payable to the Kansas State Board of Healing Arts and send all payments to the attention of: Licensing Audit Coordinator, Kansas State Board of Healing Arts, 800 SW Jackson, Lower Level-Suite A, Topeka, Kansas 66612.

21. Licensee shall have completed 12 hours of continuing education and submit proof of completion to the Board within 90 days following service of this Summary Order.

22. Licensee's license shall be suspended for failure to provide proof of the continuing education requirements and/or payment of the fine within the timeframe specified above.

23. The Board shall maintain jurisdiction over this matter to issue any Order(s) deemed necessary and appropriate.


