FINAL ORDER

NOW, on this 21st day of June, 2008, comes on for before the Kansas State Board of Healing Arts ("Board") the Application for Licensure to practice medicine and surgery in the state of Kansas filed by Stephen Oppenheimer, M.D. ("Applicant"). Applicant appears *pro se* by teleconference. Katy Lenahan, Licensing Administrator, presents information to the Board. There are no other appearances.

After reviewing the file, hearing the information provided by Ms. Lenahan and the testimony of Applicant, and being otherwise duly advised in the premises, the Board makes the following findings and orders.

1. On or about October 29, 2007, Applicant filed an Application for Licensure to practice medicine and surgery in the state of Kansas.
2. As part of his application, Applicant provided proof that he graduated from the University of London, Guys King College Medical School, England on July 15, 1980.
3. Applicant has also provided information that he currently holds full and unrestricted licenses to practice medicine and surgery in 14 states and telemedicine licenses in two states.

4. Applicant meets all of the requirements for licensure under K.S.A. 65-2873 with the exception of subsection (d) which requires an applicant from a foreign medical school to pass an examination given by the Educational Commission for Foreign Medical Graduates.

5. Applicant has passed the examinations required by the provincial medical licensing authorities of Canada and has been enrolled in the Canadian Medical Register as a Licentiate of the Medical Council of Canada. Such examinations are considered by the Board to be at least equal in quality to that required in this state.

6. K.S.A. 65-2833 provides discretion to the Board to issue a license to an applicant who has been in the active practice in another state upon certificate from the licensing authority of that state certifying that the applicant license has never been limited, suspended, or revoked and that the licensee has never been censured or had other disciplinary action taken.

7. Applicant meets all of the five requirements of K.S.A. 65-2833 to receive a license by endorsement based upon the certifications of his licenses provided by 14 states.

8. Applicant's Application for Licensure should be granted.


IT IS THEREFORE ORDERED that Applicant is eligible for license by endorsement under the provisions of K.S.A. 65-2833 and his Application for Licensure is granted.

PLEASE TAKE NOTICE that this is a Final Order. A Final Order is effective upon service. A party to an agency proceeding may seek judicial review of a Final Order by filing a petition in District Court as authorized under the Kansas Act for Judicial

Review and Civil Enforcement of Agency Actions, K.S.A. 77-601 *et seq.* A petition for judicial review is not timely unless filed within 30 days following service of the Final Order. A copy of any such petition must be served upon the Board addressed to the Executive Director, 235 S. Topeka Boulevard, Topeka, Kansas 66603. A request for reconsideration is not a prerequisite to judicial review.


