**JOURNAL ENTRY OF SATISFACTION OF SURRENDER OF DEA LICENSE**

COMES NOW the Kansas State Board of Healing Arts (“Board”), by and through its Executive Director, Kathleen Selzler Lippert, a duly authorized representative of the Board, in accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-501 *et seq.*, as amended, and upon due consideration of the agency record and applicable statutes and regulations, and being otherwise duly advised in the premises, makes the following determinations:

1. On or about October 13, 2015, Licensee entered into a Consent Order with the Board for alleged violations of the Kansas Healing Arts Act, K.S.A. 65-2801, *et seq.* The Consent Order required Licensee to surrender is DEA license indefinitely within ten (10) days of the approval of the Consent Order.


2. On or about October 9, 2015, Licensee surrendered to the Board his DEA license.

3. The Consent Order’s requirements that Licensee is indefinitely prohibited and limited from ordering, prescribing, dispensing, distributing and/or administering any controlled substance in Schedules II, III, IV, and V of the Controlled Substance Act remain in force and effect with the Board pursuant to the October 13, 2015 Consent Order.

**IT IS THEREFORE ORDERED** that Licensee is hereby discharged from the surrender of his DEA license as set forth in the Consent Order filed on October 13, 2015.
