ORDER OF RETROACTIVE REINSTATEMENT OF REGISTRATION

NOW on this 8th day of December, 1995, comes on for consideration before the Kansas State Board of Healing Arts (hereafter "Board"), sitting as a whole in a conference hearing, the request of Timothy J. Otter, R.T. (hereinafter "Registrant") for retroactive reinstatement of active registration.

Charlene K. Abbott, Licensing Administrator, presents information to the Kansas Board of Healing Arts (hereinafter "Board"). Registrant appears in person *pro se*.

After reviewing the request and being otherwise duly advised in the premises, the Board finds as follows:

1. Registrant's registration was cancelled for non-renewal on May 11, 1995. Said registration was originally issued on August 7, 1993.
2. Registrant's Application for Reinstatement was received by the Board on November 1, 1995.
3. During conference hearing on this matter, Registrant requested that the Board retroactively reinstate his registration to practice respiratory therapy to May 11, 1995.
4. The failure of Registrant to renew his registration and the cancellation of such registration was due to inadvertence and mistake on the part of Registrant.

ORDER OF RETROACTIVE REINSTATEMENT OF REGISTRATION

IT IS THEREFORE BY THE BOARD ORDERED as follows:

A. That the findings here and above made be and the same are made the Order of the Board.


B. That registration number 16-01493 issued to Timothy J. Otter, R.T., cancelled on May 11, 1995, be retroactively reinstated to May 11, 1995 to reflect that Registrant has continuously held a current registration from and since May 11, 1995.

C. That as a condition of the aforementioned retroactive reinstatement of registration, an administrative fine in the amount of fifty dollars (\$50) be assessed to Registrant for inadvertence and mistake in allowing his registration to be cancelled for non-renewal on May 11, 1995. Payment of said fine is to be received in the board office within thirty (30) days of service of this Order.

D. This is a Final Order and is effective upon service upon the parties. Any party may, within fifteen (15) days after service, file a Petition for Reconsideration. The filing of a Petition for Reconsideration is not a prerequisite for seeking administrative or judicial review.

IT IS SO ORDERED.


