**ORDER TERMINATING STIPULATION
AND AGREEMENT AND ENFORCEMENT ORDER**

NOW ON THIS 17th day of October, 1998, comes for conference hearing before the Board of Healing Arts ("Board") the request of Leslie F. Page, D.O., (hereinafter "Licensee") that the **Stipulation and Agreement and Enforcement Order**, filed August 19, 1996, be terminated. Stacy L. Cook appeared for the Board. Dr. Page appeared on her own behalf.

After examining the files, hearing statements of the parties and being otherwise duly advised, the Board finds as follows:

- 1) A Stipulation and Agreement and Enforcement Order was entered into between Licensee and the Board on August 19, 1996.
- 2) Licensee has complied with the conditions and limitations placed upon her license.
- 3) Since Licensee has not practiced obstetrics for approximately five years, the Board is concerned about Licensees ability to safely practice in that specialty area. However, Licensee testified that she has no present intent to deliver babies or to provide comprehensive prenatal care now or in the future. Should that intent change, the Board hopes that Licensee will approach the Board to re-visit this finding. Therefore, a limitation upon Licensees license is not necessary as a

means to protect the public health, safety and welfare.

4) The **Stipulation and Agreement and Enforcement Order**, filed on August 19, 1996, should be terminated.

NOW THEREFORE, it is ordered by the Board that the findings hereinabove made be and the same are hereby made the order of the Board; that the **Stipulation and Agreement and Enforcement Order**, filed August 19, 1996, is hereby terminated.

IT IS SO ORDERED.


