**ORDER GRANTING RECONSIDERATION IN PART AND DENYING
RECONSIDERATION IN PART, AND ORDER GRANTING
WITHDRAWAL OF APPLICATION**

NOW on this 17th day of July, 2013, comes before the Kansas State Board of Healing Arts ("Board") the request for reconsideration of the Final Order Denying Licensure filed by Sandhya Pahuja, M.D. ("Applicant"). Kathleen Selzler Lippert, Executive Director, a duly authorized representative of the Board, in accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-529(b), and upon due consideration of the agency record and applicable law, and being otherwise duly advised in the premises, makes the following determinations:

1. Applicant submitted an application for licensure by endorsement to practice medicine and surgery in the State of Kansas. Such application was complete and filed with the Board on or about April 29, 2013.

2. Upon consideration of such application at the June 14, 2013 conference hearing, the Board issued its Final Order on June 24, 2013, denying Applicant's application for licensure by endorsement due to the Applicant not actively engaging in the practice of medicine under her Kentucky license as required by K.S.A. 65-2833(d).


3. On or about June, 27, 2013, Applicant made a timely request pursuant to K.S.A. 77-529 for reconsideration of the Final Order denying her licensure by endorsement.

The statements of Applicant in her request for reconsideration do not provide additional evidence to warrant reconsideration of whether Applicant meets the requirements for licensure by endorsement. The request for reconsideration does provide a sufficient basis to reconsider the denial of licensure and instead allow Applicant to withdraw her application.

IT IS THEREFORE ORDERED, BY THE KANSAS STATE BOARD OF HEALING ARTS that Applicant's request for reconsideration is **GRANTED IN PART** to allow Applicant to withdraw her application for licensure by endorsement in lieu of denial. It is further ordered that Applicant's request for reconsideration is **DENIED IN PART** as to whether Applicant meets the requirements for licensure by endorsement.


