FINAL ORDER DENYING SECOND TEMPORARY REGISTRATION

NOW, on this 12th day of August, 2000, this matter comes on for conference proceedings before the Kansas Board of Healing Arts (hereafter "Board") at the request of Kyle L. Parks, (hereafter "Applicant") to grant a second temporary registration pursuant to K.S.A. 65-2896d.

Charlene K. Abbott, Licensing Administrator, presented information before the Board. Applicant appeared *pro se*.

After hearing statements from the parties and being duly advised in the premises, the Board makes the following findings of fact, conclusion of law and orders:

1. A request for a second temporary registration was submitted by Applicant on June 27, 2000 and a Conference Hearing was set for 10:45 a.m. on August 12, 2000.
2. Applicant has applied for permanent registration as a physician's assistant, but has not passed an exam approved by the Board as required by K.S.A. 65-2896a(a)(3).
3. On January 19, 2000, Applicant was granted a temporary registration which will expire August 31, 2000.
4. Pursuant to K.S.A. 65-2896d, not more than one temporary registration shall be permitted to any one person without the majority approval of the members of the Board.

5. In April 2000, applicant took the examination approved by the Board and required for permanent registration. Applicant's score was substantially below the minimum passing score.

IT IS THEREFORE ORDERED as follows:

1. Applicant's request for a second temporary registration is DENIED.
2. This is a Final Order and is effective upon service upon the parties. Any party may, within fifteen (15) days of service, file a Petition for Reconsideration. The filing of a Petition for Reconsideration is not a prerequisite for seeking administrative or judicial review.

IT IS SO ORDERED.


