#### PROPOSED DEFAULT ORDER

**NOW,** on this 23<sup>rd</sup> day of February, 2002, comes before the Kansas Board of Healing Arts, (hereafter "Board") a Petition to revoke, suspend, censure or otherwise limit the license of Jagdish P. Parmar, M.D., (hereafter "Licensee"). Licensee does not appear either in person or through counsel.

The Board finds Licensee in default for his failure to attend and participate in the hearing. The allegations of fact as stated in the Petition are adopted as the Board's findings of fact. The Board finds and concludes as follows:

1. Licensee's medical license in the state of Alabama was revoked by an Order of the Alabama Board of Medical Examiners. The revocation was based on the finding that Licensee had refused to appear before the Alabama Board when formally requested to do so. Pursuant to K.S.A. 2001 Supp. 65-2836(j), the Board has the authority to revoke, suspend, censure or otherwise limit Licensee's license due to Licensee's license having been revoked by the proper licensing authority of another state.

2. Licensee answered "no" to the disciplinary question on his July 1, 2001 to June 30, 2002 Kansas Renewal Application which asked "Since May 1, 2000, has any disciplinary action been taken or initiated against you by a state licensing agency?" On his renewal application, signed July 8, 2001, Licensee misrepresented that disciplinary action had not been initiated by the Alabama Board, when in fact, such action had been initiated on June 4, 2001. Committing fraud or misrepresentation when applying for renewal of a license to practice the healing arts constitutes grounds for discipline under K.S.A. 2001 Supp. 65-2836(a).

IT IS THEREFORE ORDERED, that the license of Jagdish P. Parmar, M.D. is revoked.

PLEASE TAKE NOTICE that this is a Proposed Default Order. A party against whom a Proposed Default Order is issued, may file a Motion to vacate the order. A Motion to vacate the Proposed Default Order must be filed with the Executive Director, 235 S. Topeka Boulevard, Topeka, Kansas 66603. Any such motion is not timely unless filed within 7 days following service of the Proposed Default Order. If no timely Motion to vacate the Proposed Default Order is received, the Proposed Default Order becomes the Board's Final Order without further proceedings or notice.

2. Respondent did not attend the Conference Hearing conducted on February 23, 2002, at which time the Board found Respondent to be in default and issued a Proposed Default Order which was filed on March 8, 2002.

3. A copy of the Proposed Default Order was mailed to the Respondent on March 8, 2002 at Respondent's mailing address in West Carrolton, Ohio. The Proposed Default Order was not returned in the mail to the Board office as undeliverable.

4. K.S.A. 77-520 provides that a party against whom a Proposed Default Order is issued may file a written motion within seven days after service of the order requesting that the order be vacated and if a motion is not so filed, the Proposed Default Order shall become effective.

5. Respondent has not filed a motion requesting that the Proposed Default Order be vacated

and, therefore, by operation of law, the Proposed Default Order became effective March 8, 2002, and Respondent's license to practice medicine and surgery in the State of Kansas is revoked as of that date.
