FINAL ORDER

NOW, on this 19th day of June, 2004, this matter comes before the Kansaas State Board of Healing Arts, (hereafter "Board") the request submitted by Rina S. Patel (hereafter "Applicant") to withdraw her Application for a License to Practice as a Physical Therapist in the state of Kansas. Charlene K. Abbott, Licensing Administrator, presented information to the Board. Applicant did not appear.

After reviewing the file and being duly advised in the premises, the Board finds and orders as follows:

- 1. Applicant filed as Application for Registration as a Physical Therapist with the Board on October 9, 2003.
- 2. On February 26, 2004, the Board's Executive Director issued a Summary Order Denying Application.
- 3. On March 4, 2004, a letter from Applicant was received in which she requested reconsideration of the Summary Order, which request was considered as a request for hearing under K.S.A. 77-542.
- 4. On March 5, 2004, a Notice of Conference Hearing was filed setting Applicant's application for a conference hearing at 10:00 a.m. on Saturday, April 17, 2004.

5. On April 1, 2004, amendments to the physical therapy statutes became effective which

changed the credentialing of physical therapists from registered to licensed and Applicant's applicant

was considered to be an Application for License as a Physical Therapist.

o. On April 17, 2004, a letter was received from Applicant advising that she would not be

able to appear for the hearing and an Amended Notice of Conference Hearing was filed on April 19,

2004 continuing the conference hearing until 9:00 a.m. on June 19, 2004.

7. On June 14, 2004, the Board received a letter addressed to the Board's Licensing

Administrator advising that she was withdrawing her application temporarily.

8. The Board finds that the Applicant's request to withdraw her application should be

granted.

IT IS THEREFORE ORDERED that Applicant's Application for a License to Practice as

a Physical Therapist has been voluntarily withdrawn and no further proceedings are required or

necessary.
