**COMES NOW** the Kansas State Board of Healing Arts ("Board"), by and through its Executive Director, Kathleen Selzler Lippert, in accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-501 *et seq.*, as amended, and upon due consideration of the agency record and the applicable law, and otherwise being duly advised in the premises, makes the following determinations:

- 1. Applicant's last known mailing address provided to the Board is 404 Pennell, Carl Junction, Missouri, 67834.
- 2. Applicant was originally issued License No. 16-03175 on April 29, 2005, to practice respiratory therapy in the State of Kansas.
- 3. On May 15, 2007, Applicant was randomly selected to provide proof of her continuing education hours to the Board. Applicant failed to provide the requested information, and as a result, a Summary Order was issued cancelling her license for failure to provide the requested information.
- 4. On or about January 13, 2012, Applicant submitted an application to reinstate her license to practice respiratory therapy in the State of Kansas. Such application was deemed complete and filed with the Board on May 23, 2012.

5. On or about May 23, 2012, Respondent filed a Response in Opposition to Application for Reinstatement to Practice Respiratory Therapy ("Response"). The allegations set

forth in the Response are incorporated herein by reference in their entirety.

6. Applicant was served with a copy of the Response on or about May 23, 2012, by

United States mail, first-class postage prepaid.

7. A conference hearing regarding the Application for Reinstatement was scheduled

to be held on June 22, 2012, at the offices of the Kansas State Board of Healing Arts.

8. Pursuant to K.S.A. 2010 Supp. 77-531, Applicant was served with a Notice of

Conference Hearing to Applicant's mailing address via United States Mail, first-class postage

prepaid, on or about May 30, 2012.

9. The Notice of Conference Hearing provided Licensee notice that any party who

fails to attend or participate in the Conference Hearing or other stage of a proceeding may be

held in default.

10. Applicant failed to appear at the Conference Hearing on June 22, 2012.

11. Pursuant to K.S.A. 77-516 and K.S.A. 2010 Supp. 77-520, Applicant was in

default for her failure to appear at the conference hearing on June 22, 2012. Upon review of the

agency record and after being fully advised, the Board found and concluded that the facts and

allegations set forth in the Response in Opposition to Application for Reinstatement to Practice

Respiratory Therapy were deemed undisputed.

12. On July 18, 2012, a Proposed Default Order was issued against Applicant and

copies of the Proposed Default Order were mailed to Applicant's mailing addresses by United

States Mail, first-class postage prepaid.

Pursuant to K.S.A. 2010 Supp. 77-520, the Proposed Default Order notified Applicant that the order would become effective as a Final Order of the Board seven (7) calendar days following service of the order, unless within that seven (7) day period Licensee filed a written motion with the Board requesting that the proposed default order be vacated.

14. Applicant failed to file a Motion to Vacate the Proposed Default Order within the seven (7) day period following service of the order.

15. Pursuant to K.S.A. 77-520 and 77-531, the Proposed Default Order became effective as a Final Order on July 30, 2012, and Applicant's application for reinstatement of license to practice respiratory therapy in the State of Kansas was **DENIED**.

Pursuant to the authority granted to the Board by the Kansas Respiratory Therapy Act, K.S.A. 65-5501, and in accordance with the provisions of the Kansas Administrative Procedure Act K.S.A. 77-501 *et seq.*, the Board hereby enters this Default Order in the above-captioned matter.

Having the agency record before it, the Board finds, concludes, and orders as follows:
