**ORDER TERMINATING STIPULATION  
AND AGREEMENT AND ENFORCEMENT ORDER**

NOW, on this 22nd day of June, 1996, comes on before the Kansas Board of Healing Arts ("Board") the request of Jeanne G. Pees, P.T. ("Registrant") that the **Stipulation and Agreement and Enforcement Order** filed on July 27, 1995, be terminated.

After examining the files, hearing statements of Registrant and being otherwise duly advised in the premises, the Board finds as follows:

1) A Stipulation and Agreement and Enforcement Order ("Stipulation") was filed between Registrant and the Board on July 27, 1995.

2) At its regularly scheduled meeting on April 29, 1995, the Board approved the reinstatement of Registrant's registration on the condition she agree to a Stipulation and Agreement to practice in association with another Kansas licensed physical therapist for one year.

3) The Stipulation was prepared and signed by Registrant on July 5, 1995.

4) Paragraph 5 of said Stipulation states that the conditions specified shall be in full force and effect for a period of one year.

4) Registrant has been in compliance with said Stipulation since April 29, 1995.

**NOW, THEREFORE,** it is ordered by the Board that the findings hereinabove made be and the same are hereby made the order of the Board; that the **Stipulation and Agreement and Enforcement Order** agreed to on April 29, 1995 and filed on July 5, 1995 is hereby terminated; that Registrant is released from the provisions as set forth in the **Stipulation and Agreement and Enforcement Order** and that any and all restrictions and limitations which were imposed on Registrant's registration to practice physical therapy in the State of Kansas by virtue of the **Stipulation and Agreement and Enforcement Order** are hereby removed.
