COMES NOW the Kansas State Board of Healing Arts (“Board”), by and through its Executive Director, Kathleen Selzler Lippert, in accordance with the Kansas Administrative Procedure Act, K.S.A. 77-501 *et seq.*, as amended, and upon consideration of the file, and being otherwise duly advised in the premises, makes the following determinations:

1. Karla Deane Peter, P.T. (“Licensee”) has, since approximately October 14, 1995, maintained License No. 11-02214 to engage in the practice of physical therapy in the State of Kansas.
2. On October 27, 2010, Licensee entered into a Consent Order with the Board. Under the terms of the Consent Order, Licensee was required to attend and successfully complete one (1) continuing education course on record-keeping and one (1) continuing education course on physical therapy supervision at Licensee’s expense. Licensee was further required to provide proof of successful completion of these courses to the Board by December 17, 2011.
3. On or about December 5, 2011, Licensee submitted proof of successful completion of both continuing education courses required by the Consent Order.
4. Licensee has satisfactorily met all requirements of the Consent Order and has no

further obligation for compliance.

IT IS THEREFORE ORDERED that Licensee is hereby discharged from all requirements of the Consent Order filed on October 27, 2011.
