FINAL ORDER FOLLOWING CONFERENCE HEARING

NOW, on this 3rd day of June, 2000, comes on for consideration before the Kansas Board of Healing Arts (hereafter "Board"), sitting as a whole as Presiding Officer in a conference proceeding pursuant to the provisions of K.S.A. 77-533, the request of David S. Pfoff, M.D. (hereafter "Licensee") for retroactive reinstatement of license. Licensee appears in person.

After reviewing the request and being otherwise duly advised in the premises, the Board finds as follows:

1. Licensee was originally granted license number 04-16837 to practice medicine and surgery in the State of Kansas on December 11, 1976.
2. Licensee's license was canceled on August 1, 1999 pursuant to K.S.A. 65-2809 due to Licensee's failure to renew.
3. Licensee became aware of the cancellation of his license on or about March 28, 2000, immediately contacted the Board office and completed and returned the application required to reinstate his license.
4. Licensee's application for reinstatement was received in the Board office and his license was reinstated on April 18, 2000.

5. From August 1, 1999 until April 18, 2000, Licensee maintained professional liability insurance in compliance with Kansas law and had the required continuing education necessary to qualify for reinstatement.
6. By letter dated April 20, 2000 and received in the Board office on April 24, 2000, Licensee requested that the Board retroactively reinstate his license to practice medicine and surgery to August 1, 1999.
7. The failure of Licensee to renew his license and the cancellation of such license on August 1, 1999 was due to inadvertency and mistake of Licensee.


IT IS THEREFORE BY THE BOARD ORDERED AS FOLLOWS:

- a. That the findings here and above be and the same are the order of the Board.
- b. That license number 04-16837 issued under K.S.A. 65-2831 to David S. Pfoff, M.D. and originally reinstated April 18, 2000, be retroactively reinstated to August 1, 1999 to reflect that Licensee has continuously held a current license from and since August 1, 1999.
- c. That as a condition of the aforementioned retroactive reinstatement of license, an administrative fine in the amount of three hundred dollars (\$300) be assessed to Licensee for his inadvertence and mistake in allowing his license to be canceled for non-renewal on August 1, 1999. Payment of said fine to be received in the Board office within thirty (30) days of service of this Order.
- d. This is a Final Order and is effective upon service upon the parties. Any party may, within fifteen (15) days after service, file a Petition for Reconsideration. The filing of a Petition for Reconsideration is not a prerequisite for seeking administrative or judicial review.

IT IS SO ORDERED.
