**FINAL ORDER DENYING LICENSEE'S
MOTION TO TERMINATE STIPULATION**

NOW ON THIS 11th day of December, 1999, comes on for Conference Hearing before the Kansas State Board of Healing Arts ("Board"), the request of Omprakash B. Pillai, M.D. ("Licensee"), that the "Stipulation" be terminated. Shawn Rogers, attorney, appeared on behalf of Licensee, who was also present. Kelli J. Benintendi, Associate Counsel, appeared before the Board.

After examining the files, hearing statements of the parties, and being otherwise duly advised in the premises, the Board finds as follows:

1. On April 13, 1998, an Initial Order by Agreement was entered into between Licensee and the Board.
2. The Initial Order by Agreement places several limitations on Licensee's license to practice the healing arts in Kansas.
3. On October 22, 1999, Licensee requested termination of the terms of the "Stipulation." The correct title of the document is the "Initial Order by Agreement."
4. Notice of Conference Hearing setting this matter for hearing at 9:15 a.m. on December 11, 1999, was filed herein on November 23, 1999, and served upon Licensee.

5. It is solely within the Board's discretion whether to grant Licensee's request to terminate the limitations contained in the Initial Order by Agreement entered into on April 13, 1998.

6. There was evidence presented at the hearing that Licensee had an incident of inappropriate behavior with a female medical student, which occurred very shortly after Licensee entered into the Initial Order by Agreement in April of 1998.

8. After hearing the statements from the parties, the Board is not satisfied that the limitations imposed by the Initial Order by Agreement should be terminated.



A petition for judicial review is not timely unless filed within thirty (30) days following service of the Final Order. A petition for judicial review of a Final Order must be served upon the Executive Director of the Board. Reconsideration is not a prerequisite to judicial review.
