NOTICE OF RETROACTIVE REINSTATEMENT OF REGISTRATION

NOW, on this 29th day of April, 1995, this matter comes on for consideration before the Kansas State Board of Healing Arts (hereafter "Board"), sitting as a whole as Presiding Officer in a conference proceeding pursuant to the provisions of K.S.A. 77-533, the April 12, 1995 request of Wendi K. Pippitt, R.T. (hereafter "Registrant") for retroactive reinstatement of registration. Kevin K. LaChance, Disciplinary Counsel, appeared before the Board. Registrant did not appear.

After hearing statements of counsel and being otherwise duly advised in the premises, the Board finds as follows:

1) Registrant failed to renew registration no. 16-01496 which was originally issued on August 7, 1993, and which expired on December 31, 1993, and was subsequently cancelled on February 22, 1994, pursuant to K.A.R. 100-55-6.

2) Pursuant to Board records, Registrant applied for reinstatement on May 24, 1994.

3) The Application for Reinstatement was deemed complete on September 19, 1994 and the registration of Registrant was reinstated effective that date.

4) From February 22, 1994, until September 19, 1994, Registrant held herself out as a respiratory therapist in violation of K.S.A. 65-5514.

5) By letter received April 12, 1995, Registrant requested that the Board retroactively reinstate her registration as a respiratory therapist from February 22, 1994 until the date of reinstatement, September 19, 1994.

6) The failure of Registrant to renew registration no. 16-01496 and the cancellation of such registration on February 22, 1994 was due to misunderstanding on the part of Registrant of the renewal process.

IT IS THEREFORE BY THE BOARD ORDERED as follows:

A. That the findings here and above made be and the same are made the Order of the Board.

B. That registration number 16-01496 issued to Wendi K. Pippitt, cancelled on February 22, 1994 and reinstated on September 19, 1994, be retroactively reinstated to February 22, 1994 and that the records of the Board be amended to reflect that Registrant has continuously held a current registration from and since August 7, 1993.

C. This is a Final Order and is effective upon service upon the parties. Any party may, within fifteen (15) days after

service, file a Petition for Reconsideration. The filing of a Petition for Reconsideration is not a prerequisite for seeking administrative or judicial review.

IT IS SO ORDERED.
