# FINAL ORDER TERMINATING MONITORING

2. On January 10, 2017, the Respondent Board filed a Response to Petition for Termination of Monitoring.

3. The Board finds that the Licensee has satisfactorily met all requirements of the Consent Order and concludes that termination of the monitoring requirement is warranted in the circumstances.
