NOW on this 31 day of Aug, 2010, this matter comes before Kathleen Selzler Lippert, Executive Director, Kansas Board of Healing Arts ("Board"), concerning Licensee's satisfaction of all requirements contained in the Consent Order Licensee entered into with the Board which was filed on April 20, 2010. Wherefore, the Board finds as follows:

1. On or about April 20, 2010, Licensee entered into a Consent Order with the Board to address concerns regarding Licensee using the designation AT without being properly licensed. The Consent Order contained a provision for Licensee to pay a civil fine in the amount of \$250 due and payable in full by September 15, 2010.

2. Licensee submitted five payments of \$50 each on May 11, 2010; May 25, 2010; July 1, 2010; August 2, 2010 and August 30, 2010.

3. Licensee has satisfied all requirements of the Consent Order and has no further obligation for compliance.

IT IS THEREFORE ORDERED that Licensee is hereby discharged from the requirements of the Consent Order filed on April 20, 2010.


NOTICE OF RIGHTS


