**FINAL ORDER TERMINATING MONITORING**

NOW, on this 12<sup>th</sup> day of August 2011, comes before the Kansas State Board of Healing Arts ("Board") the request of Jessica Pounds, PT ("Licensee") for termination of the monitoring provisions imposed by the Consent Order previously entered in KSBHA Docket No. 10-HA00131. Licensee appears *pro se*. Lori A. Dougherty, Associate Litigation Counsel, appears on behalf of the Respondent Board.

Pursuant to the authority granted to the Board by the Kansas Healing Arts Act, K.S.A. 65-5501, *et seq.*, and in accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-501, *et seq.*, the Board hereby enters this Final Order following a conference hearing in the above-captioned matter. After reviewing the file, hearing the testimony and arguments of the parties, and being otherwise duly advised in the premises, the Board makes the following findings of fact, conclusions of law and order:

**I. Findings**

1. Jessica Pounds, PT ("Licensee"), is licensed practice respiratory therapy in the State of Kansas, License No. 16-03923, and has been so licensed since approximately April 28, 2010.

2. Licensee's last known mailing address provided to the Board is: confidential  
Street, Lenexa, Kansas 66125.

3. On or about November 13, 2009, Licensee submitted to the Board her application for licensure to practice respiratory therapy in the State of Kansas.

4. On or about February 23, 2010, Licensee entered into a Consent Order with the Board, **confidential**

**confidential** Under the terms of the Consent Order, the Board approved Licensee's request for a license to practice as a respiratory therapist in the State of Kansas.

5. The terms of the Consent Order allow Licensee to petition the Board for modification or termination of the Order after a one (1) year month monitoring period.

6. On or about June 15, 2011, Licensee submitted a request to terminate the monitoring requirement.

7. On July 6, 2011, the Respondent Board filed a Response to Licensee's Request in support of termination.

8. Licensee has demonstrated compliance with the Consent Order for a period of over one (1) year.

## **III. Conclusions of Law**


9. Licensee has satisfactorily met all requirements of the Consent Order and has no further obligation for compliance.

## **V. Order**


