FINAL ORDER FOLLOWING SUMMARY PROCEEDINGS

NOW, on this 18th day of October, 1997, this matter comes before the Kansas State Board of Healing Arts (hereinafter referred to as "Board") sitting as a whole, the application of Deborah Elizabeth Powell, M.D., (hereinafter "Applicant") for a permanent license to practice medicine and surgery in the State of Kansas.

Applicant appeared in person pro se. Charlene Abbott, Licensing Administrator of the Board, presented information to the Board.

After reviewing the file, hearing statements and being otherwise duly advised in the premises, the Board finds as follows:

1. On April 28, 1997, Applicant filed an Application for Endorsement to obtain a permanent license to practice medicine and surgery in the State of Kansas.
2. As part of that application, Applicant was asked to provide information pertaining to her passage of the National Boards. Applicant has provided proof of passage of parts I and II of National Boards. Applicant stated that she had not taken Part III of the National Boards.
3. Applicant stated that in 1965 she was doing her residency at Georgetown University Medical Center in Washington D.C. and was encouraged to take the District of Columbia

licensing exam instead of Part III of the National Boards.

4. The District of Columbia licensing exam was equal in quality to Part III of the National Boards, which was the examination required in the state at that time.

5. Applicant has held medical licenses in Kentucky, Maryland, and the District of Columbia and is entitled to endorsement under K.S.A. 65-2833.

IT IS THEREFORE ORDERED as follows:

(a) That Applicant has met the requirements to receive a license to practice medicine and surgery in the State of Kansas upon the submission of proof of receiving a passing score on the District of Columbia Special Examination.

(b) Either party is entitled to an administrative review of this Order if written request is received in the Board office within fifteen (15) day of service of this Order upon the parties.

IT IS SO ORDERED.


