ORDER RESCINDING STIPULATION

NOW on this 12th day of December, 1988, comes on for hearing the request of Yanyong Prakalapakorn, M.D. (hereinafter referred to as "Licensee"), before Richard G. Gannon, serving as presiding officer in summary adjudicative proceedings pursuant to K.S.A. 1987 Supp. 77-540.

After reviewing the file and being otherwise duly advised in the premises, the Kansas State Board of Healing Arts, by and through its Executive Director, Richard G. Gannon, serving as presiding officer finds as follows:

1. That on or about December 5, 1986, Licensee entered into a Stipulation with the Board which, inter alia required Licensee to obtain additional education and report all obstetrical cases on a monthly basis to the Board for monitoring.

2. That Licensee has requested that the aforementioned Stipulation be rescinded.

3. That from and since the entry of the Stipulation, it appears that Licensee has fully and completely complied with all of the requirements of the Stipulation.

4. That the Stipulation between the parties dated December 5, 1986, should be rescinded in its entirety and hereafter declared null and void and of no further force and effect.

5. That with the rescission of the Stipulation, the license to practice medicine and surgery issued to Licensee shall be without any limitations or restrictions.


IT IS THEREFORE ORDERED BY THE BOARD that the Stipulation dated December 5, 1986, between Licensee and Board be rescinded in its entirety and shall hereafter be null and void and of no further force and effect and that the license of Licensee to practice medicine and surgery in the State of Kansas shall hereafter be without any restrictions or limitations.

Further, Licensee may request an administrative review of

this Order if made within 15 (fifteen) days after service upon Licensee.
